Structure of the Institute

INEKO was established as a member of INEKO Group which was created by several existing research institutes: The Center for Economic Development (CPHR, or CED), Transparency International Slovakia (TIS), Business Alliance of Slovakia (PAS), Junior Achievement Slovakia (JAS) and Slovak Governance Institute (SGI).

The intensity of cooperation within INEKO Group reached its peak between 2000 and 2003, when INEKO largely financed the infrastructure of INEKO Group members (rent, energy, office equipment, phone, internet, etc.). In 2004 this support was gradually declining and ceased completely since 2005. Nowadays, all members cover their entire infrastructure individually. However, some institutes cooperate further on an informal (discussions, consultations) as well as formal basis (common projects, personal appointments).


INEKO was founded in 1999 by Katarina Vajdová, Daniela Zemanovicová, and Eugen Jurzyca, who all became also original members of the General Assembly. In 2020, the General Assembly had following members: Rastislav Kováčik, Daniela Zemanovičová, and Peter Goliaš.

The Institute is governed by the Board and managed by a Director. The Board has a rotation membership lasting 5 years. Since August 2018, the Board has had following members: Gabriel Šipoš, Róbert Kičina, Luboš Vagač, Dušan Zachar and Peter Goliaš. The Board members meet irregularly to discuss the results of INEKO projects and plans for the future. The Director has been appointed by the Board and the Board members have been appointed by the General Assembly.

The Institute budget supports these broad functions: the management, infrastructure and service staff to coordinate effective policy research, and selected projects.

The Institute's initiative responds to the serious need for independent Slovak support for the economic reform challenges facing the government and the regional entities in the time of implementing the crucial structural reforms. This support is many times not available from understaffed public bureaucracies or existing private organizations.

The Institute has developed a small-specialized staff, which also draws on existing capacity in cooperating organizations. Its work involves identifying barriers to economic efficiency and developing policies designed to remove these barriers. The staff development aims at deepening the know-how in the process of preparation and implementation of reforms. INEKO staff knowledge develops mainly through on-the-job-learning while working on particular reform projects, studying relevant literature and, though financially limited, attending international conferences.

Mission & Environment

Mission: The Institute's mission is to support a rational and efficient economic and social reform process in the Slovak Republic (SR), through research, information development and dissemination, advice to senior government, political and self-governing officials, and promotion of the public discourse. It also focuses on those areas of social policy on the regional as well as the European level critical to the economic transformation of the SR. It draws on the best experience available from other transition countries and members of the European Union (EU) and the OECD.

Environment: In 2020, the work of INEKO was influenced mainly by following factors: (1) Impact of COVID-19 pandemic on the economy and society; (2) Parliamentary elections in March 2020 resulting in change of the government and activation of anti-corruption and pro-reform movement in the executive; (3) Weakening of the long-term sustainability of the public finances; (4) Growing demand for informing and engaging citizens in monitoring the quality of public services; and (5) Demand for exporting INEKO reform know-how abroad. Thus, the Institute focused on monitoring and supporting the design and implementation of effective and efficient anti-corona measures; strengthening democracy through public education, anti-corruption effort, and support of transparent and independent public institutions; monitoring public finance sustainability; decreasing the information asymmetry in education, health care, municipal finance, and public transport; and exporting the Slovak reform know-how abroad. Continuously, we were monitoring and analyzing proposed changes in other areas such as health care, labor market, pension system, social benefits system, etc.

Peter Goliaš was born in Liptovský Hrádok, Slovakia in 1977. Before 2010 he worked at INEKO as an economic analyst. His areas of interest include monitoring and analyzing the reforms of pensions, health care, education, labor market, and public finance as well as promotion of democracy, market economy and transparency in the public sphere. As a Consultant to the Slovak Ministry of Labour he participated in the pension reform project funded by the World Bank. He worked also as a Consultant to the Slovak Ministers of Education and Finance. He is an author of numerous studies and articles on the topics above. He is a member of the Strategic Committee at the Business Alliance of Slovakia, Steering Committee at the Slovak Association of Economic Analysts and Steering Committee at the Free Enterprise & Democracy Network. Before 2002 he worked as an economic journalist at the local daily Pravda and the private press agency SITA. He graduated from the Faculty of Management, Comenius University in Bratislava and holds Magister (MA) degree.

Program

The focus of work supported by the Institute is being determined by a careful analysis of public opinion, government priorities and options as well as by the analysis of the Brussels policy. It has already changed and will be a continually changing agenda. In 2020, issues at the center of Slovak government concern and relevant to the Institute's activities included:

- Resolving the impact of COVID-19 pandemic on the economy and society
- Anti-corruption efforts
- Public finance stabilization
- Construction of transport infrastructure, esp. highways
- Health care reform;
- Reform of education;
- Social security reform (including pensions).

The Institute has developed a small-specialized staff, which together with the General Assembly members and other Board members developed the agenda of Institute activities. Its work involves identifying barriers to economic efficiency and developing policies designed to remove these barriers. The identified barriers include:

- Negative impact of the COVID-19 pandemic on the economy and society
- High popularity of the populist and anti-democratic forces in politics;
- Eroding independence of key regulatory, audit and judiciary institutions
- Lack of transparency in preparation of the biggest transport infrastructure projects;
- Information asymmetry in education and healthcare;
- Lack of high-quality reform-related information.
- High level of public finance deficit and debt;

Through research, analysis, expert forums and working groups, public discussion and other means, the Institute develops policy options and strategies for presenting these effectively to the relevant audiences. It should be able to provide some of the policy development services that the public administration cannot. By providing feedback on government economic and social measures, organizational support, additional financial resources for research and project development, and coordination of presentations to public officials the Institute has a significant influence on the private, non-commercial contribution to policy.

PROJECTS

Supporting Democracy in Slovakia

The project was launched in September 2016 and was financially supported by the Centre for International Private Enterprise (CIPE) in Washington, The Representation of Konrad Adenauer Foundation in Slovakia, The Representation of the European Commission in Slovakia and The Eset Foundation. The goal is to analyze the state and development of democracy including the independence of key public institutions, to propose recommendations for fostering democracy, fostering the independence and professionalism of key public institutions as well as to promote democratic consciousness in Slovakia.

The project was performed in cooperation with the Business Alliance of Slovakia (BAS).

In 2020 we realized following major activities:

Summary:

The project helped to raise awareness about the state of democracy in Slovakia and about the most necessary changes needed to improve the democracy and independence of key audit, regulatory and judiciary institutions. It helped the public and media to better understand the link between the democracy and the quality of life. It also helped the policy makers and the representatives of various institutions to better understand the weaknesses in independence of specific institutions and to identify solutions. The project helped to share this knowledge directly through lectures and discussions with several hundred students from secondary schools all across Slovakia as well as through consultations with chief representatives of particular institutions and policy makers. Indirectly, the project reached to tens of thousands of

readers of INEKO blogs, Facebook posts and internet portal. Additionally, many more people have been reached by media mentions relevant to the project.

Informing and engaging citizens in monitoring the financial health of local governments as well as the quality and efficiency in education, health-care, and public transport

Project description: Collecting, assessing and publishing data with the aim to decrease information asymmetry in education, health care, municipal finance, and public transport; evaluating the financial health of local governments, results of pupils at primary and secondary schools, quality and efficiency of health-care providers as well as the big projects in building the transport infrastructure; informing the citizens and engaging them in monitoring.

Project duration: 04/2018 – 03/2020

Project results in 2020:

Monitoring big projects in transport: The project supported a quality of media coverage and deepened public debate on the biggest government projects by delivery of formerly missing information. The project unmasked the fact, that ministry of transport officials rather promises dozens of projects without financial coverage than seek for appropriate and more feasible transport solutions. We published several analytical articles and blogs on anti-competitive practices in tenders, overpricing and wasting public funds. Some of our findings were quoted in hundreds of reports in TV, radio, print and internet media. The project helped to strengthen transparency, public awareness and thus reduce the space for plundering public funds in big projects in the future. It has also brought synergies with “value for money” initiative that became part of current government program declaration. In 2020 we provided key information on approximately 100 highway sections and dozens of railway sections currently in use, under construction or planning through the unique internet portal presenting an interactive map of highways and railways in Slovakia: <https://doprava.ineko.sk/mapa/cesty>.

Monitoring Financial Health of Slovak Municipalities: In December 2011, INEKO launched a project aimed at increasing pressure to improve financial health of Slovak municipalities. In 2020 we updated and substantially upgraded the portal <http://www.hospodarenieobci.sk/> presenting economic data of all municipalities and higher regional units in Slovakia including unique assessment of their financial health. We added data for 2019 and substantially expanded the coverage by adding all economic data of regions and municipalities as well as their subsidiaries. We also published the analyses of financial stability of 50 biggest Slovak municipalities and 8 higher regional units (VÚC). The partner of this activity is PosAm, s.r.o.

Internet Portal on Primary and Secondary Schools: The project offers relevant information about all primary and secondary schools in Slovakia. This is done via special internet portal (launched in 2012): <http://skoly.ineko.sk/>. We believe, that when people have more relevant information, they can make better decisions. It is our opinion that the project helps not only parents and future pupils, but also the schools, because they will be able to compare themselves and get motivated to improve their results. Monitoring Quality and Efficiency of Hospitals: In November 2014 we launched an internet portal assessing quality and efficiency of the Slovak hospitals - <http://nemocnice.ineko.sk/>. The project offers relevant information about all hospitals in Slovakia. It includes information about quality and efficiency indicators including transparency and competitiveness in public procurement, waiting periods for operations, satisfaction of patients, death rates for various diagnoses, financial health indicators, etc. According to this information the public can create effective pressure on this status improvement. Monitoring and Commenting on the Structural Reforms

In 2020, INEKO continued in **monitoring and commenting on the structural reforms in Slovakia**. The main goal of the project is to help the broad public as well as the experts and the journalists to get a quick and clear overview of the structural reforms. It contributes to the discussion about the outcomes of these reforms so that possible mistakes or pitfalls are avoided. In 2020, we focused particularly on government measures aimed at resolving the impact of COVID-19 pandemic on the economy and society, proposals to strengthen sustainability of public finances, as well as modifications of the pension, health care, tax, labor market, and education systems.

In 2020, we continued in our project "**Discussing the problems of health care and potential solutions (i-health.sk webpage)**" with our local partner – private health insurance company Dôvera. The goal of the project is to identify key problems of the Slovak health care system, to research best foreign practices and to propose solutions to the problems. Thus, it should improve the quality of the public as well as expert discussion of the Slovak health care system. The results of the project are displayed on a web page www.i-health.sk and published in the local media. In 2020, the project included monitoring of main developments on local market, writing analysis and presenting key results in media.

In 2020 we published an updated analysis on the Current state and possibilities for more intensive use of generic and biosimilar medicines in Slovakia. The analysis identified potential savings of up to 50 million EUR annually in case of more intensive uses of generic and biosimilar medicines. It was widely quoted by local media.

The project builds on earlier activities of INEKO in Ukraine supported by the SlovakAid and the US Embassy in Kyiv over October 15, 2015 – March 31, 2018. The activities focused mainly on raising the transparency and financial stability of local governments in Ukraine.

Objectives: The project goal is to increase transparency and support implementation of anti-corruption measures in state-owned companies and local governments in Ukraine. Informed citizens and corruption-resistant public authorities are basic conditions for higher efficiency of the state, higher engagement of citizens and better democracy. The project is based on transfer of know-how of unique and successful projects implemented in Slovakia focused on monitoring and expert assessment of local socio-economic measures, as well as on easy-to-understand informing about transparency and financial stability of state-owned companies and local authorities.

The specific objectives of the project are:

1. Increasing the quality of regional regulations through regular expert assessment of social and economic measures adopted on local level
2. Supporting the implementation of anti-corruption measures and improving the public oversight of state-owned companies and self-governments by assessment of their transparency and active cooperation to implement the measures
3. Improving the financial stability of state-owned firms and self-governments by assessment of their financial health

Strengthening democratic resilience of key public institutions in Ukraine

The project builds on earlier activities of INEKO in Ukraine supported by the SlovakAid and the US Embassy in Kyiv over October 15, 2015 – March 31, 2020. The activities focused mainly on raising the transparency and financial stability of local governments and public enterprises in Ukraine.

Objectives:

The main goal is to increase transparency and independence of key regulatory and judiciary institutions as well as transparency and financial stability of the biggest state-owned enterprises and local governments in Ukraine. This will be done by transferring the Slovak know-how in following areas:

1. Evaluation of independence of at least 15 regulatory and judiciary institutions;
2. Evaluation of transparency and financial health of at least 50 biggest public enterprises;
3. Evaluation of transparency and financial health of at least 50 biggest cities and 22 regions.

The evaluations will lead to specific recommendations how to foster independence and transparency of key institutions. The publicity of evaluations, together with the expert advice and sharing the best practices will strengthen incentives and conditions necessary for successful implementation of recommendations and anti-corruption measures. This will help to increase transparency and democratic resilience of institutions evaluated under the program.

Objectives: The project goal is to support public debate about current state of democracy, to strengthen the independence of key regulatory and judiciary institutions as well as to increase transparency and support implementation of anti-corruption measures in state-owned companies and local governments in Moldova. Informed citizens and corruption-resistant public authorities are basic conditions for reducing risk of “state capture”, increasing efficiency of the state, increasing engagement of citizens and improving democracy.

Specific goals and activities:

- Supporting public debate about current state of democracy based on available data, results of a survey among key personalities, focus groups, and results of a representative public opinion poll
- Supporting and evaluating the independence and transparency of key regulatory and judiciary institutions including open selection process of their leaders
- Increasing transparency, supporting the implementation of anti-corruption measures and improving the financial stability of state-owned companies and self-governments

Duration: September 2020 – June 2021

Objectives: The main goal is to enhance the representation of the local business community across Slovakia in the decentralization debate by collecting private sector input and drafting its priorities in this regard. Specific objectives:

- Collecting private sector input on issues related to the decentralization reform and the government response to COVID-19 through six country-wide business surveys supplemented by informal group interviews, as needed. Writing and publishing reports on results of the surveys.
- Based on the research related to the private sector priorities for the decentralization debate and the government response to COVID19, subsequent outreach and advocacy, and given the developments of the decentralization reform debate and the pandemic, INEKO will produce analysis on the key findings and private sector priorities for the decentralization debate.
- Regarding the findings of these surveys and the analysis, INEKO will then conduct associated traditional and online media outreach including a seminar to present the analysis (with all relevant stakeholders).



- f. Ján Kovalčík was member of the expert group advising in transport related issues at Žilina region.


